**WALK INS:** \$20.00 Walk in registration fee if not registering online

**CHECKS PAYABLE TO:** Tri County Wrestling Club (For WALK INS ONLY)

**ADMISSION:** Adults - \$3.00 Students - \$2.00 Kindergarten & Under - Free

**BRACKETING:** Brackets made using Track Wrestling. 4 man round robin brackets with 10% weight tolerance where possible.

**AWARDS:** Trophies to first place winners. Medals to all other places in each weight bracket. No team scores will be kept.

**MATS:** There will be 6 mat areas available.

**MATCH TIME:** 3 – One minute periods per match for PreK-6<sup>th</sup> Grade. 30-second ride out in the event of a tie. 3-90 second periods for 7<sup>th</sup> & 8<sup>th</sup> Grade. 1 minute sudden victory in the event of a tie. If still tied, 30-second ride out.

**RULES:** Folkstyle rules and scoring will be used
