- ALL must be checked in by 4:30 pm. NO ENTRIES WILL BE ACCEPTED AFTER THIS TIME.
- AAU/USA/Huskerland insurance is required for all wrestlers; please show your insurance card at check in. If no insurance card, wrestler will not wrestle.

Format: There will be four man round robin brackets. Wrestlers will be grouped as close as possible within approximately 5 lbs, with no set weight classes. Divisions will have three matches per wrestler when possible. To challenge reasonable weight difference, is an additional \$20. If you win you get money back and challengee pays.

Note: Wrestlers not checked in by above times will be scratched! All wrestlers must send in their actual weight. There will be random weigh-ins at time of meet; if wrestler does not make weight, a **\$10 Re-Bracket Fee** will be assessed!

Girls & Preschool-2nd: Three 60 second periods. All periods start in neutral position with first period scoring. The first period will be wrestled even if a pin occurs before time runs out.

3rd-8th: Three 60 second periods with choice in the second and third periods.

7th-8th: Three 90 second periods with choice in the second and third periods.

Rules: Overtime will go by high school rules. Tech fall at 12 points. Hair, skin and fingernails will be checked at check-in.

Appropriate sportsmanship with be enforced. Unsportsmanlike conduct will result in dismissal from the meet without refund of tournament fee. Tournament director will address these issues. All tournament help is volunteer, we will do our best to host a quality tournament.
