**Scoring:** Folk style rules; 3 – one minute periods for Pre-6<sup>th</sup> grades. 3 - 90 second periods for 7<sup>th</sup> – 8<sup>th</sup> grades. Overtime will be decided with sudden death.

**Bracketing:** 4 man round robin brackets will be used in divisions where possible. All wrestlers will wrestle three times where possible.

**Awards:** Trophies will be awarded for 1<sup>st</sup> place. Medals will be awarded 2<sup>nd</sup> through 4<sup>th</sup> place.
