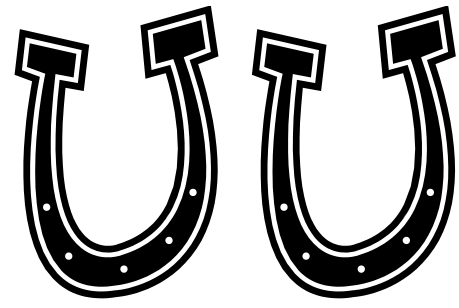


# 13<sup>th</sup> Annual Centennial Wrestling Club

3<sup>rd</sup> - 4<sup>th</sup> grade and under will wrestle (3) 60 second periods, all starting neutral.  
 5<sup>th</sup> – 6<sup>th</sup> will wrestle (3) 60 second periods with choice in the 2<sup>nd</sup> & 3<sup>rd</sup> periods.  
 7<sup>th</sup>-8<sup>th</sup> grades will wrestle (3) 90-second periods with choice in the 2<sup>nd</sup> & 3<sup>rd</sup> periods. **Full mats!**
