SCORING: NHSAA Folkstyle rules will apply. Three 1 minute periods for Pre K-6th, 7th & 8th will have 3-90 second periods with choice in 2nd and 3rd periods. Overtime will be decided by sudden death.

AWARDS: Medals awarded to 1st – 4th places

Everyone will weigh in. Bracketing will not be done until after weigh-ins.
